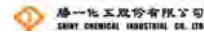

Facing Taiwan Strait to the west and Bashi Channel to the south, Kaohsiung is a beautiful and modern metropolis located in southern Taiwan as well as the second largest city of the island. Greater Kaohsiung, a metropolis occupying an area of 2,946 km² with the total population of 2.77 million, possessing all kinds of natural landscapes and living facilities, will thrive as a new global city.



Kaohsiung has the largest land area of any special municipality of Taiwan. 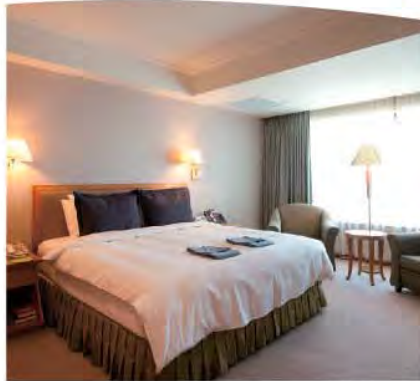

Blue Economies:

Effects, Implications and Roadmap for Asia Pacific Cities

The world is ready for re-industrialization. The strategy to compete on the basis of cost has led to an economic model where the bad is cheap and junk dominates. This leads to material and energy inefficiency and a massive waste generation. The cases of the Blue Economy demonstrate that reindustrialization is viable.

Gunter Pauli (1956) obtained his masters in business administration from INSEAD, Fontainebleau, France. His entrepreneurial activities span business, culture, science, politics and the environment. Under his leadership, a small European company pioneered an ecological factory. He founded the "Zero Emissions Research and Initiatives" (ZERI) at the United Nations University in Tokyo, and subsequently established The Global ZERI Network, redesigning production and consumption into clusters of industries inspired by natural systems. He is dedicated to design and implement a society and industries, which respond to people's needs using what is available from nature. Fluent in seven languages, and having lived on four continents, he is a world citizen. He has written sixteen books, which have been printed in 27 languages and 36 fables bringing science and emotions to children. Over 17 million copies have been distributed worldwide. A few of his fables are available in over 100 languages.

Green Economies: Effects, Implications and Roadmap for Asia Pacific Cities



BRAUNGART, Michael

Founder, Environmental Protection Encouragement Agency (EPEA) / Co-Author of "Cradle to Cradle"

Imagine a world in which industry, yes, every factory and every building is as wasteful and as useful as a cherry tree in full bloom. A world, in which buildings – just like trees – use the sun's energy, produce nutrients and oxygen, provide living space for other creatures, cleanse water, purify the air and even change to adapt to the seasons. "Cradle to Cradle" offers a paradigm-shift to holistic quality and innovation.

Michael Braungart is a chemist, author, and founder of EPEA (Environmental Protection Encouragement Agency) International in Hamburg, Germany, and cofounder of MBDC (McDonough Braungart Design Chemistry) in Charlottesville, Virginia. Both EPEA and MBDC share a common set of values that embraces intelligent, aesthetic, and eco-effective design. Through these activities, Braungart has developed tools to design eco-effective products and business systems and has worked with a number of organizations and companies in a range of industries. Since 1994, Professor Braungart has been teaching process engineering at the University of Lüneburg in Suderburg, Germany, also serving as director of an interdisciplinary materials-flow management masters program.

After completing his studies in Process Engineering in Darmstadt, Germany, Dr. Braungart went on to explore the chemical processes of industrial production techniques with the Chemistry Department at Konstanz, Germany. He subsequently spearheaded the formation of the Chemistry Section of Greenpeace International. By the time he completed his PhD in Chemistry at the University of Hannover in 1985, he had assumed leadership of Greenpeace Chemistry.

In 1987, Dr. Braungart founded the Environmental Protection Encouragement Agency (EPEA) in Hamburg. At the heart of EPEA is the "Intelligent Products System" (IPS), which creates products oriented toward a life-cycle economy and earned the Océ-van der Grinten Award in 1993.

In addition to his achievements within the EPEA, Dr. Braungart also serves as Scientific Manager of the Hamburg Environmental Institute, the non-profit research center which produces the "Top 50 Study": an evaluation of the environmental performance of the world's largest chemical companies.

He coauthored the book "Cradle to Cradle: Remaking the Way We Make Things" with architect William McDonough in 2002. In 2003, he was awarded the Presidential Green Chemistry Challenge Award for his work with EcoWorx carpeting tile. He has also accepted a visiting professorship at the Darden School of Business, lecturing on such topics as eco-efficiency and eco-effectiveness, "Cradle to Cradle" design and Intelligent Materials Pooling, and he continues to teach at institutions of higher learning all over the world.

Madam Chu Chen, Mayor of Kaohsiung City, is one of the main characters in the democratization of Taiwan. Before the Democratic Progressive Party is established, Madam Chen devoted herself to democratic movements in Taiwan as one of the very few female who took the risk to participate in politics.

Since 1991 she has served several major positions within the government. Democracy and human rights have always been her core value, with emphasis on equality, dignity and rights of the people, such as social welfare and working rights.

In 2006, Madam Chen was elected as the Mayor of Kaohsiung City. As the first female mayor of direct-controlled municipality in Taiwan, she marked an essential milestone in the history of female participation in politics.

From the day Madam Chen assumed office, she has always been listening to the citizens' voice and emphasizing on human rights. Kaohsiung City earned the title of "human right city" by the People's Movement for Human Rights Learning (PDHRE). Afterwards, Kaohsiung City Human Rights Commission was established on February 28th, 2009.

In 2009, over 5,000 athletes and coaches from 103 countries participated in the 2009 World Games in Kaohsiung. The 8th World Games has won extremely high evaluation from the international community. In the same year, Kaohsiung City won the second place in the city competitiveness evaluation by the Commonwealth Magazine.

Following his appointment as Lord Mayor of Brisbane in April 2011, Graham Quirk was elected as Lord Mayor in the 2012 Brisbane City Council election.

Graham has a long record of service to Brisbane and the local community, being first elected to Council in 1985. As a member of Civic Cabinet for more than a decade, he has overseen key portfolios of infrastructure and finance, as well as serving as Deputy Mayor alongside Campbell Newman from 2008.

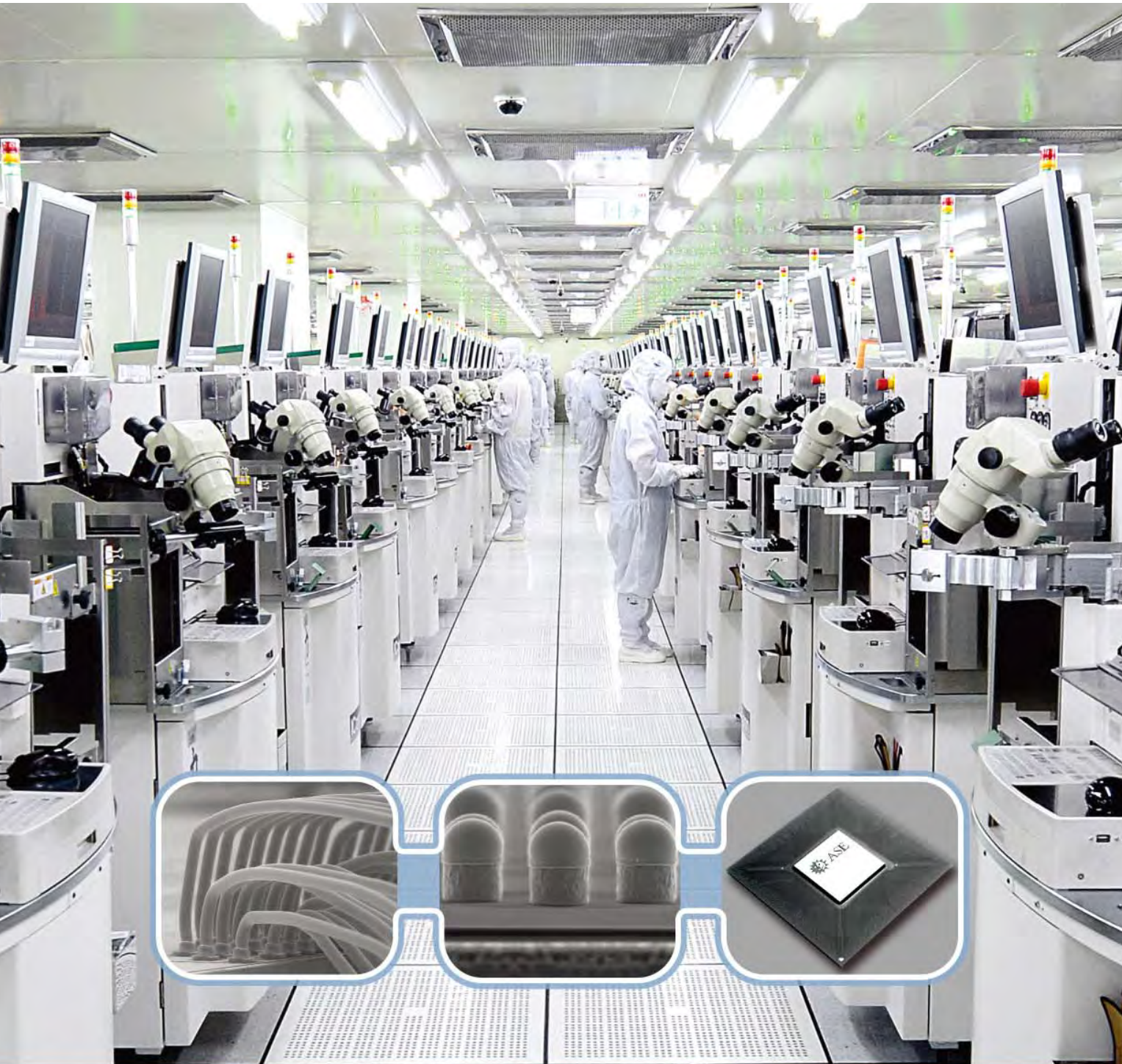

Over the next 40 years cities will grow from the present situation where half the world's population are city dwellers to a point where at least three quarters of humanity live in cities. This will require successful strategies to tackle the provision of housing, transport and employment opportunities for the new inhabitants.

Ken was born in Lambeth, South London in 1945. He began his political career serving on Lambeth and Camden Councils before becoming leader of the GLC in 1981 until Margaret Thatcher abolished it in 1986. He then served as Labour MP for Brent East from 1987 to 2001.

Ken was elected as the newly created Mayor of London in May 2000, and was re-elected for a second term in June 2004. He had the courage and vision to initiate the transformation of the city's aging transport infrastructure. He championed and became the driving force behind the capital's successful 2012 Olympic bid, leading to the regeneration of the entire east London area.

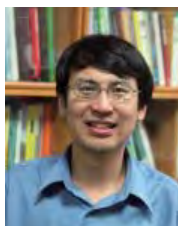

Bi-khim Hsiao is a Member of the Legislative Yuan of Taiwan, representing the Democratic Progressive Party (DPP) and serving as a legislator at-large. Currently, Bi-khim is a member of the Legislative Yuan Foreign and National Defense Committee and the Secretary General of the Parliamentary Cross-Party Group on International Human Rights. She is also the Vice President of the DPP Think Tank - New Frontier Foundation, a Board Member of the Taiwan Foundation for Democracy and a Board Member of the Strait Exchange Foundation on DPP's behalf. Bi-khim has been an effective spokesperson on Taiwan issues for international media, think tanks and foreign government visitors to Taiwan. She has also been active in various inter-parliamentary networks and international political party organizations.

Bi-khim Hsiao served as Director of DPP's International Affairs Department under six different DPP Chairpersons. After Taiwan's first democratic change of government in 2000, she became Advisor in the Office of the President. She has also served as Campaign Director and Spokesperson for DPP International Affairs in all of the presidential elections since 2000.

In addition to representing Taiwan, Bi-khim has also taken numerous leadership roles in international organizations. She served as Secretary General of the Council of Asian Liberals and Democrats (CALD) from 2004 to 2005. She was the Vice President of the Liberal International (LI) Bureau from 2005 to 2012. In 2008, she served as Vice Chairperson of the Taiwan Tibet Exchange Foundation and later founded Friends of Tibet in the Legislative Yuan in 2012, advocating for rights of Tibetans.

Understanding the need for a holistic approach to a nation's development, Bi-khim is committed to providing service to the rural areas of Taiwan where she has long been an advocate for poverty reduction, access to education, sustainable governance and other measures to enable the pursuit of a fair and just society. Bi-khim has dedicated herself to improving the well-being of Taiwan's eastern coast. She has been outspoken on issues related to local agriculture, transportation, youth employment, education, indigenous rights, gender equality, immigrant rights, and animal welfare.

Born in Kobe, Japan, in 1971, Bi-khim Hsiao grew up in Tainan, a city in southern Taiwan. She received her MA in Political Science from Columbia University and her BA in East Asian Studies from Oberlin College.

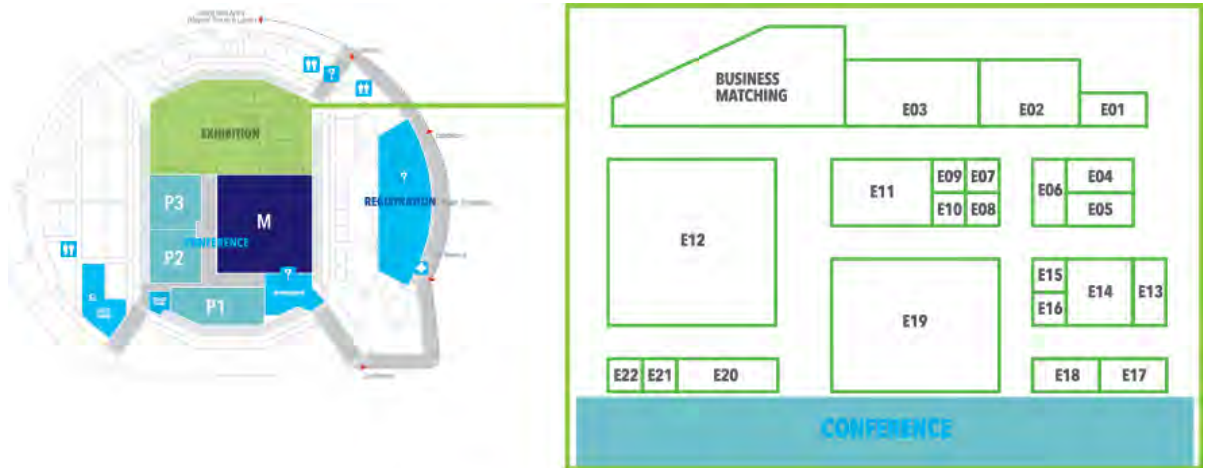

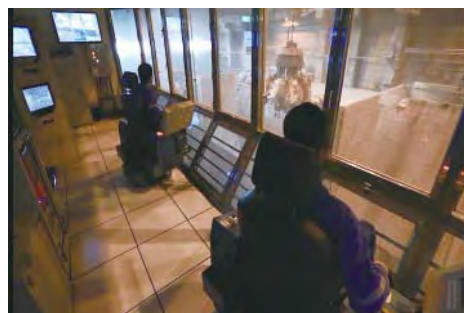

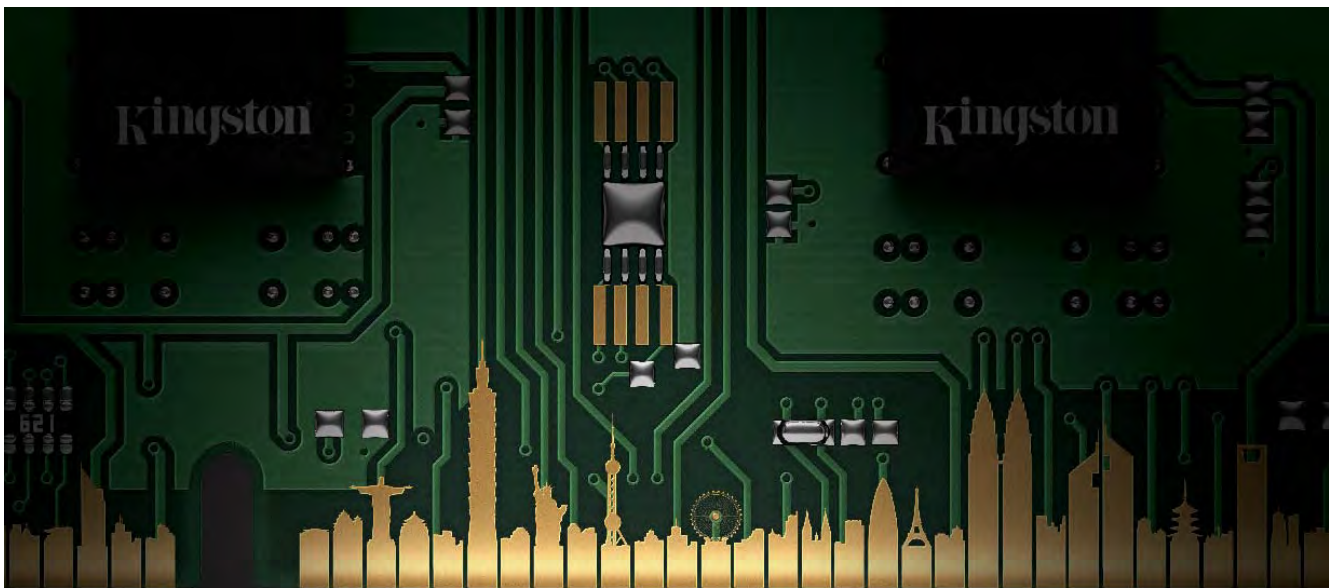

General Information

Time Zone

Taiwan is 8 hours ahead of Greenwich Mean Time (GMT+0800). There is no daylight saving time in Taiwan.

Climate

Taiwan's climate is subtropical in the north and tropical in the south. The average temperature for September is around 28°C to 32°C in Kaohsiung. As nights might get cool and air conditioning will be provided in most premises, delegates are recommended to bring a thin jacket or cardigan. Kaohsiung is one of the sunniest areas in Taiwan; participants are advised to bring sun protection.

Electricity

The utility power supply used in Taiwan is 110 volts/60 Hz. Power outlets are with two flat parallel pin plugs, type A. Appliances from Europe, Australia or South-East Asia will require an adaptor and/or transformer. You can usually borrow a multi-purpose plug from the hotel.

Language

The official language of Taiwan is Mandarin Chinese, though other dialects are also spoken. Many people can speak in English, but taxi drivers may only speak Mandarin. Taking name cards of the hotel and/or destination written in Chinese are recommended.

Currency

The local currency is the New Taiwan Dollar (NTD). The current exchange rates are about 1 USD to 30 NTD and 1 EUR to 40 NTD (2013/08, subject to change). Major foreign currencies can be exchanged at airports, designated banks, shopping malls and hotels.

Credit cards

Most of the major credit cards are accepted in most hotels, shops and restaurants. Most widely accepted credit cards are Visa and MasterCard. Restaurants and shops generally display signs indicating which cards are accepted. Taiwan has a national network of cash machines (ATMs), from which you can withdraw cash 24 hours a day.

Tipping and Taxes

Tipping is not customary under most of the circumstances in Taiwan. It is however usual to tip hotel porters and for restaurant services. Mostly, a 5% value-added tax will be added to the price, and a 10% service charge might be added depending on the policy of the hotel or restaurant.

Transportation

Bus, metro (MRT) and taxi services are offered in main cities. Bus Services from airports to the City Centre are provided. Delegates arriving at Kaohsiung International Airport are able to take the metro (MRT) to the city centre. High Speed Rail (HSR) is available to travel rapidly inland from North to South.

Travelling and Visa Requirements

The island is accessible by most international airline companies. Visa may be required. Delegates are strongly advised to consult travel agents and/or the Taiwan Embassy, Mission or Consulate in the home country in case of doubt. Please note, that you are required to hold an international passport with a minimum valid period of 6 months (3 months for Japanese passport holders) to enter Taiwan.

Wi-Fi

Free public Wi-Fi access is provided across public areas as MRT or bus stations around Taiwan (TPE-Free, iTaiwan). Visitors who wish to use the service can register an account with valid passport or entry permit at Tourist Information Centres. In addition to the free Wi-Fi access, payable Wi-Fi accesses are also available in most of 7-11 convenience stores across Taiwan, and in coffee shops and restaurants like Starbucks or McDonald's. Prepaid access cards can be purchased over the counter at the stores, and the costs are varied.

Free Wi-Fi access will be provided at the venue.
